Report on Financial Statements

We have audited the accompanying financial statements of the business type activities of the Idaho Health Insurance Exchange dba Your Health Idaho ("YHI"), as of and for the years ended June 30, 2016 and 2015, and the related notes to the financial statements, which collectively comprise The Idaho Health Insurance Exchange dba Your Health Idaho's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audits. We conducted our audits in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including assessments of the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to Idaho Health Insurance Exchange dba Your Health Idaho's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Idaho Health Insurance Exchange dba Your Health Idaho's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall

Opinions

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the business type activities of the Idaho Health Insurance Exchange dba Your Health Idaho as of June 30, 2016 and 2015, and the respective changes in financial position and cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis information on pages 6-9 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Information

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Idaho Health Insurance Exchange's basic financial statements. The schedule of expenditures of federal awards is presented for purposes of additional analysis as required by Title 2 U.S. Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, and is also not a required part of the basic financial statements.

The schedule of expenditures of federal awards are the responsibility of management and were derived from and relate directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the schedule of expenditures of federal awards are fairly stated in all material respects in relation to the basic financial statements as a whole.

Other Reporting Required by *Government Auditing Standards*

In accordance with *Government Auditing Standards*, we have also issued our report dated September 20, 2016, on our consideration of the Idaho Health Insurance Exchange dba Your Health Idaho's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. MANAGEMENT'S DISCUSSION AND ANALYSIS

June 30, 2016 and 2015

Within this section of the Idaho Health Insurance Exchange, dba Your Health Idaho ("YHI") financial report, YHI's management provides narrative discussion and analysis of the financial activities of YHI for the year ended June 30, 2016 and 2015. YHI's financial performance is discussed and analyzed within the context of the accompanying financial statements and disclosure following this section.

YHI is considered an enterprise fund and accounted for using the economic resources measurement focus and the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as applied to governmental units. The financial statements are designed to provide the readers with a broad overview of the YHI's finances, in a manner similar to a private-sector business.

Revenues are recorded when earned, and expenses are recorded at the time liabilities are incurred. YHI, regardless of the timing of cash flows, applies all applicable Governmental Accounting Standards Board (GASB) pronouncements.

Per the establishing legislation, House Bill 248, YHI cannot rely on any funding from any state agency. As such, YHI is required to generate revenue on an ongoing basis from the fees earned on policies generated from YHI's website. In the interim period, YHI will rely upon federal grants to cover the costs associated with establishment activities and the capital investments necessary. The remaining operating costs will be covered by revenue from assessment fees and existing cash reserves.

FINANCIAL HIGHLIGHTS

YHI reported assets of \$35,704,019 for the year ended June 30, 2016, an \$8,545,567 decrease from 2015. The decrease in assets is driven primarily by a \$7,762,449 increase in Accumulated Depreciation (offset by an additional capital investment of \$4,752,637) and a \$7,224,080 decrease in Grants Receivable. YHI held cash of \$7,613,098 and grant receivables of \$2,147,778. These assets will be used to meet YHI's obligations to vendors.

Liabilities and Net Position of \$35,704,019 consisted of short-term payables and accrued expenses of \$3,030,024 and a Net Position of \$32,673,995, a \$2,113,983 decrease from 2015. The Net Position change was due to the decrease in the net investment in capital assets of \$3,014,619, and an increase in unrestricted assets of \$900,636.

YHI incurred operational expenses of \$22,598,410 related to the establishment and operation of the entity. Operational expenses include, but are not limited to, the following key areas of operation:

- Professional services of \$7,120,045, a decrease of \$12,386,433 from 2015, which includes general business consulting, legal and technology consulting related to the implementation of the YHI marketplace technology;
- Marketing and advertising of \$1,996,204, a decrease of \$2,144,057 from 2015. Marketing efforts include outreach and education, earned media, website maintenance, public relations and related consulting;
- Consumer Support Services of \$3,372,857, an increase of \$801,242 compared to 2015. The current year expenses included costs for the services of the In Person Assistors and Tribal engagement costs, call center services and related travel and training. The increase is due primarily to a full twelve months use of the DHW Call Center in FY 2016 compared to only six months use in FY 2015;
- Payroll and related expenses of \$1,906,273, an increase of \$722,865 from 2015 driven by increased YHI headcount; and
- Depreciation expense of \$7,762,449, an increase of \$2,299,686 over 2015, due to the increased capital technology investment (\$22,456,599 in 2015 and \$4,579,824 in 2016).

As mentioned above, YHI, per enabling legislation HB248, is restricted from using any state resources to fund its operations. As such, YHI has created a five year financial forecast to evaluate the long-term sustainability of the exchange. Excluding federal grant funds, YHI currently relies on a single source of revenue, assessment fees, which are earned on policies generated from YHI's website. In April 2015, the Board approved an assessment fee increase from the rate of 1.50% (effective through December 31, 2015) to 1.99% was assessed for effectuations effective January 1, 2016. . On June 17, 2016, the Board approved the integration of the Customer Support Center within YHI's operations. These functions were previously performed by the Idaho Department of Health and Welfare as part of the Eligibility Shared Services agreement.

As Federal Grant funding decreases over the next eighteen months, YHI will rely on assessment fee revenues to operate the exchange. YHI's current financial projections assume that operating expenses will exceed assessment fee revenue by approximately \$1.7M in financial year 2017. YHI has over \$7.6M in cash reserves, approximately \$1.6M higher than projected at this time last year and management will access cash reserves as needed to cover any shortfall.

Due to YHI's capital assets acquired during YHI's establishment period, YHI is projecting to incur significant depreciation expenses associated with the YHI Marketplace technology as it is amortized over the life of the asset. As such, YHI is projecting a reduction in Net Position over the next two financial years. YHI's reduction in Net Position does not indicate cause for concern for the long-term sustainability of the exchange.

At the end of the 2016 financial year, YHI has one Federal Government grants to be used for establishment activities. As of June 30, 2016, YHI currently has approximately \$15,355,055 remaining from its third Federal Government grant. As such, YHI expects to continue to receive funding from this Federal Government grant for establishment activities into financial year 2017. YHI expects to utilize the Federal Government grant fund for additional capital investment and as such, will continue to see an increase in capital assets through the end of financial year 2017. These expenditures are related to several existing multi-year contracts with vendors to complete the build out phase of the health insurance technology and related establishment activities. In addition to the capital investment and establishment activities, YHI will utilize assessment fee revenues to fund operational activities during this same time period. After financial year 2017, YHI's operations are expected to be funded solely from the assessment fees collected from the insurance carriers.

NOTE A - SIGNIFICANT ACCOUNTING POLICIES

Financial Reporting Entity

Idaho Health Insurance Exchange dba Your Health Idaho (“YHI”) was created as an independent body corporate politic, meaning a “government entity”, by the Idaho State Legislature under the provisions of House Bill No. 248. The Act empowers YHI to enhance Idaho residents’ access to health insurance, by establishing a state-created, market-driven health insurance exchange that will facilitate the voluntary selection of individual and employer health benefit plans.

Although the State of Idaho considers YHI to be a component unit for financial reporting purposes in accordance with GASB Statement No. 14, *The Financial Reporting Entity*, and 39, *Determining Whether Certain Organizations are Component Units*, and the State’s governor appoints the Board of Directors of YHI, YHI is legally separate from the State of Idaho, in that it is not a State agency under State law, and does not rely on State resources to support its operations.

Measurement focus, basis of accounting, and financial statement presentation

YHI is considered an enterprise fund and accounted for using the economic resources measurement focus and the accrual basis of accounting. The accounting objectives are determinations of net income, financial position and cash flow. All assets and liabilities are included on the balance sheet. YHI’s financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) as applied to governmental units using the accrual basis of accounting. Under this method, revenues are recorded when earned, and expenses are recorded at the time liabilities are incurred. YHI, regardless of the timing of cash flows, applies all applicable Governmental Accounting Standards Board (GASB) pronouncements.

Enterprise funds distinguish operating revenues and expenses from non-operating items. Operating revenues and expenses generally result from providing services and producing and delivering goods in connection with a proprietary fund’s principal ongoing operations. Federal grants related to the establishment and running of the exchange are included in operating revenues. Operating expenses for the proprietary fund include the cost of personnel and contractual services, supplies and depreciation on capital assets. All revenues and expenses not meeting this definition are reported as non-operating revenues and expenses.

Cash Equivalents

YHI considers all unrestricted, short-term, highly liquid investments purchased with a maturity of three months or less to be cash equivalents.

Assessment Revenue and Receivables

On December 12, 2013, the Board of Directors of YHI adopted the Fee Assessment Policy #1. This policy established a fee of 1.5% of the total premium due for individual and small group policies certified by the exchange and sold through the Exchange's individual marketplaces. In April 2015, the Board of Directors approved an increase to the assessment fee to 1.99%, effective January 1, 2016. The fee is assessed on and payable by the carriers. Accounts receivable as of June 30, 2016 and 2015 consist of amounts assessed that are not remitted to YHI as of year-end. YHI has not recorded an allowance for the receivable because all balances are deemed to be collectible.

Grants Receivable

Grants receivable consist of grants awarded and paid on a reimbursement basis. The receivable balance represents eligible expenses unreimbursed as of June 30, 2016 and 2015. No provision for an allowance for bad debt has been made since the grant is issued by the U.S. Department of Health and Human Services and no collection issues are anticipated by management.

Grant Revenue

YHI recognizes revenue associated with the Federal grant when the corresponding expenses have been incurred and are considered reimbursable from the grants. The grants are for the establishment and operations of YHI.

Prepaid Expenses

Certain payments to vendors reflect costs applicable to future accounting periods and are recorded as prepaid expenses.

Capital Assets

In the financial statements, fixed assets are accounted for as capital assets. All fixed assets are stated at cost, less accumulated depreciation and amortization. YHI capitalizes assets with a cost of \$5,000 individually, or for bulk purchases greater than \$10,000 or more as purchases and construction outlays occur. The costs of normal maintenance and repairs that do not add to the asset value or materially extend useful lives are not capitalized. When capital assets are disposed, the cost and applicable accumulated depreciation are removed from the respective accounts and the resulting gain or loss is recorded in operations. Capital assets are depreciated using the straight-line method over the useful lives:

Computers	3 years
Software	5 years
Furniture and Equipment	5 years

Compensated Absences

YHI provides personal leave to all full time and part time employees. It is paid to employees when taken and will also be paid to employees or their beneficiaries upon the employee's termination, retirement or death. The amount of unpaid personal leave accumulated by YHI employees is accrued as a liability in the financial statements.

Net Position

Net position is displayed in three components as follows:

Invested in capital assets, net of related debt – Consist of capital assets including restricted capital assets, net of accumulated depreciation and reduced by the outstanding balances of any bonds, mortgages, notes, or other borrowings that are attributable to the acquisition, construction, or improvement of those assets.

Restricted net position – Consist of net position with constraints placed on the use either by (1) external groups such as creditors, grantors, contributors, or laws or regulations of other governments, or (2) law through constitutional provisions or enabling legislation. There are no restricted assets as of June 30, 2016 and 2015.

Unrestricted net position – All other net position that do not meet the definition of “invested in capital assets, net of related debt” or “restricted”

Use of Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates.

Reclassifications

Certain expenses for the year ended June 30, 2015 have been reclassified to conform to the current year presentation. The reclassifications had no impact on total expenses or the change in Net Position for the year ended June 30, 2015.

Custodial Credit Risk of Cash and Investments

Custodial credit risk is the risk that in event of failure of the counterparty, YHI will not be able to recover the value of its deposits or collateral securities that are in the possession of the outside party. The Federal Deposit Insurance Corporation (FDIC), insures \$250,000 of the bank balance. In the normal course of business YHI will hold balances in excess of the insurance limits. YHI was exposed to custodial credit risk of \$2,449,217 and \$4,954,575 at June 30, 2016 and 2015, respectively.

YHI has all of its investments held through a CDARS program, administered by Idaho Independent Bank. The deposits at Idaho Independent Bank are placed in certificates of deposit among several other banks, all under the \$250,000 FDIC insurance limit. The certificates of deposits have varying terms and interest rates, however, all remain FDIC insured.

Interest Rate Risk

Interest rate risk is the risk that the changes in market interest rates will adversely impact the fair value of an investment. Generally, the longer the maturity of an investment, the greater the sensitivity of its fair value to change in market interest rates. The exchange's policy is to put investments in the CDARS Program, limiting its exposure to interest rate risk.

NOTE E - CONTINGENCIES

YHI receives grants that are subject to review and audit by the federal agency. Such audits could result in a request for reimbursement by the agency for expenditures disallowed under the terms and conditions of the agency. In the opinion of management, such disallowances, if any, will not be significant.

NOTE F - ECONOMIC DEPENDENCY

YHI receives a major portion of its revenue from Federal Government grants, during the start-up phase. The management of YHI is of the opinion that the Exchange will receive Federal funding for the cost of start-up through December 2016, after which time the Exchange will be self-funded by assessment fees payable by insurers and insurance producers who use the Exchange's facilities. Management is in the process of applying for a no-cost-extension of the grant to cover the completion of the technology beyond the December 2016 deadline.

NOTE G - VENDOR CONCENTRATION

YHI has contracted with and is dependent upon several IT consultants and companies to develop its core IT systems including but not limited to a web portal, enrollment system, and corresponding IT infrastructure. A large concentration existed with a single company. This company represented 87% and 70% of accounts payable as of June 30, 2016 and 2015, respectively.

NOTE H - RISK MANAGEMENT

YHI maintains commercial insurance coverage for directors and officers, errors and omissions, tort claims, and property loss and other casualties. Workers compensation insurance is maintained through the state insurance fund.

NOTE I - COMMITMENTS

During the years ended June 30, 2016 and 2015, YHI entered into various multi-year contract agreements relating to the development of a health insurance exchange. After December 31, 2016, operational cost are expected to be funded by assessment fees collected from the insurance carriers.

NOTE J - LEASES

YHI leases office space and equipment under non-cancellable agreements that expire at various times through June 2020. The leases require monthly payments ranging from \$3,600 to \$9,396. Future minimum lease payments as of June 30, 2016 are as follows:

NOTE K - RETIREMENT PLAN

YHI sponsors a retirement plan under section 219(G)(5)(A) of the Internal Revenue Service Code that is available to employees. YHI can contribute up to 3% of the participant's compensation in the plan year. Participants are fully vested at all times. Total employer contributions under this plan were \$29,449 and \$22,659 for the years ended June 30, 2016 and 2015, respectively.

NOTE L - RELATED PARTIES

Certain representatives from insurance carriers serve on YHI's Board. The representatives are not compensated by YHI for their services. Regence Blue Shield, an insurance company (also represented in the Board) provided medical insurance to employees of YHI during the years ended June 30, 2016 and 2015. YHI paid a total of \$151,285 and \$74,884 in premiums for the years then ended, respectively.
